**Curriculum:** Food Lure, Release, Focus, Leave-It, Drop-It, Sit, Sit/Stay, Touch Down, Down/Stay, Recall (come), Loose-Leash Walking, (Retractable leashes are NOT permitted in class) Heel, No Jumping, Mental Stimulation Games, Tricks, Focus on unwanted behaviors, Training folder provided for each dog.

☐ **Training Workshops: 1-2 Sessions - \$45-\$50**

**Curriculum:** Loose Leash Walking, Four on the Floor, No Jumping - Greetings at the door. Training folder provided for each dog. (Retractable leashes are NOT permitted in class).

**TERMS AND CONDITIONS FOR CUSTOMER AGREEMENT**  
**GROUP OR DAY TRAINING CLASSES**

1. \_\_\_\_\_ I, the owner shall complete the Tail Country Pet Resort (TCPR) Guest Information Form, Contagious Illness Policy and am responsible to provide all updated medical vaccination records and rabies certificate.
2. \_\_\_\_\_ I will provide a copy of their Rabies, DHLPP & Bordetella (kennel cough) vaccinations required before entering class.
3. \_\_\_\_\_ **If my dog is enrolled in the group training classes**, I understand that training fees are due in full at the first **group training class**.
4. \_\_\_\_\_ **If my dog is enrolled in the day training sessions**, I understand that the **day training enrollment fee** is due prior to my dog's first **day training session** and understand I have the option to pay on a weekly basis or full payment at the start of my dog's first **day training session**.
5. \_\_\_\_\_ I am required and will work with my dog at least three (3) 15-minute sessions/day on strengthening all commands taught. The reinforcement and consistency of training will increase the positive outcome of my dog's training sessions.
6. \_\_\_\_\_ I will be provided with verbal, hands on and written training instructions on how I can solve or curtail behavior problems. Training videos are available on the TCPR website and Facebook page.
7. \_\_\_\_\_ I understand that my dog must always remain on a standard 6' leash while on the property and retractable/extendable leashes are NOT permitted.
8. \_\_\_\_\_ I understand that the role I play in my dog's learning process is integral to achieving desired results. As the owner I acknowledge and agree that there is no guarantee that my dog will achieve the desired level of training, despite the best efforts of the trainers. As the owner, I understand that there are no refunds after receipt of payment. I understand that I am being trained to train my dog and that without 100% cooperation, as well as consistent reinforcement, my dog will not be fully trained. As the owner I am ultimately responsible for the dog's final outcome.
9. \_\_\_\_\_ I understand that attendance in dog obedience training is not without risk to my dog. Some of the dogs to which my dog may be exposed to may be difficult to control and may be exposed to illness associated with close contact with other dogs. I am aware of these risks and agree to then.
10. \_\_\_\_\_ I understand and agree that my dog may be videotaped, photographed, and recorded. TCPR shall be the exclusive owner of the results and have the rights to all proceeds of such tapings, photography, and recording. TCPR shall have the perpetual rights to copyright and to license any videos, photographs, and recordings to others to use in any manner. Unless I provide written notice to TCPR indicating otherwise, I agree that my dog may be used in all media, including social media, and in the promotion, advertising, sale and publicizing of TCPR.
11. \_\_\_\_\_ CANCELLATIONS: I understand I can postpone any of the lessons if a 24-hours' notice is given to the TCPR dog trainers. As the owner, I understand and agree that failure to give the TBPR dog trainers 24-hours' notice will result in a missed lesson and delay in training. Tail Country Dog Training is only obligated to give one (1) makeup training session due to the owner cancelling the session within 24-hours. Additional makeup lessons can be purchased at \$45-\$55 per session.
12. \_\_\_\_\_ TERMINATION OF TRAINING: I may have my dog withdrawn from training at any time, however, once training has begun, I understand all fees are non-refundable.
13. \_\_\_\_\_ I understand the trainers reserve the right to expel my dog from class. In these cases, private sessions may be recommended. I will fully disclose any aggressive tendencies that my dog may demonstrate in the Guest Information form.
14. \_\_\_\_\_ LIABILITY: As the legal owner/s of the above-mentioned dog, having carefully read and fully understand this agreement, do hereby waive and release Tail Country Pet Resort, LLC, Barbara Ail Noll, ABCDT, trainers and handlers from any liability and waiver of claims from any nature. This includes any injury, medical or veterinary expenses, death, sickness or damage my pet may suffer during or after any training session. I also agree to indemnify and hold harmless Tail Country Pet Resort, LLC, Barbara Ail Noll, ABCDT, trainers and handlers from any and all claims due to damage the pet may cause to any family members or any third parties during or after training.
15. \_\_\_\_\_ In the event that Tail Country Pet Resort, LLC and Barbara Ail Noll, ABCDT deems it necessary to employ legal counsel to protect its rights under this agreement, I the owner of the dog agrees to pay all expenses incurred by Tail Country Pet Resort, LLC and Barbara Ail Noll, ABCDT to enforce its rights under this agreement including, but not limited to cost and reasonable attorney's fees.

***Tail Country Pet Resort, LLC does not guarantee the outcome of any training/counseling programs. The owner assumes full and complete responsibility for the dog's behavior during and after the training/consulting program.***

***I have read and understand that all training is contingent upon the owner's willingness to handle and/or work the dog described above.***

***This training agreement represents the full and only agreement between the parties. No modifications may be made to this agreement unless in writing and signed by both parties.***
